

## The Security of Ein al-Hilweh Camp is the Responsibility of the Lebanese Authority

(Translated)

A spot of Lebanese land (Ein al-Hilweh Camp) lives in a state of killing and destruction, so that all attempts to stop the fighting have been thwarted by parties within the Lebanese authority, headed by Iran's Hezb in Lebanon. The last of these attempts was to empty the camp of those wanted by the authority by linking their file to the deal that the state had concluded with the fighters in Jarud Arsal, but this attempt was foiled by the Iran's Hezb.

The view of the Lebanese authority of Ein al-Hilweh camp is an inhumane security view that was manifested in the construction of the wall and the installation of gates. This view resembles only that of the Jewish entity towards the people of Gaza and the West Bank.

In addition, the view of Ein al-Hilweh from the sectarian racial point of view, so that at times the people of Palestine (the Muslims) are accused of inciting the Lebanese civil war, even though the near and far know that the root cause of the civil war in Lebanon is the fragility of the Lebanese entity and the deeply entrenched sectarianism in it. And at others, the Ein al-Hilweh Camp is being instigated as a threat to its surroundings and as occupying one third of the lands of the Christian town of Darb al-Sim!

The responsibility for the security of Ein al-Hilweh lies first and foremost in the Lebanese authority. And the abandonment of this authority of its responsibilities towards the people of the camp and throwing it at the powerless security committees is one of the several attempts to make the people of the camp feel despair and push them to the disgraceful reality, like the one we saw in the people of the camp protest in front of the Western embassies to open the door of immigration to them.

The weapons, ammunition and even the elements that are introduced and used in the renewed battles are not dropped from the air into the camp, but pass through the Lebanese authority's checkpoints... Thus, the Lebanese authority is the first defendant in what is happening inside the camp today. And the aim of the Authority has become more than obvious, which is to break its political and moral resolve to subject it to the security of the racists and sectarians' authority after Beirut, Sidon, Tripoli and Arsal were subjected.

The people of the Ein al-Hilweh Camp are the brothers of religion, relations and kinship, as are the people of Syria, rather, the whole of Bilad Ash-Sham, and the responsibility of their security is a political responsibility of the Lebanese state and not a security responsibility as is the case today...

The political responsibility is the responsibility of caring for those who have lived in this country on some of the so-called its sons have lived on.
