IMF COVID -19 FUNDING IS A TOOL TO SAVE THE WEST'S GLOBAL ECONOMIC COLONIALISM



The International Monetary Fund (IMF) has approved a total of \$18 billion so far to help dozens of countries bear the impact of the coronavirus pandemic, a spokesperson said on Thursday.

"Since roughly the beginning of April until May 6th, yesterday, we have approved financing for 50 countries under these emergency facilities," Gerry Rice, the head of the IMF communications department, said at a virtual press briefing.

"It's an IMF moving at an unprecedented speed in an unprecedented way to meet this unprecedented challenge, which we are all facing of course."

He said over 100 countries had requested or expressed interest in assistance from the IMF since the start of the COVID-19 crisis.The spokesperson said the fund had increased access to its emergency facilities – the rapid credit facility and the rapid financing instrument – to meet an expected global demand of \$100 billion.


Rice explained that the emergency assistance for COVID-19 was not comparable with normal IMF programs since the funds were not tied to certain conditions.

"Importantly, these facilities allow the Fund to provide emergency assistance without the need to have a full-fledged program. So, they do not entail the usual IMF conditionality," he said.

To ensure [no] misuse of funds, he said member countries were asked to commit that the money was only being used for urgent purposes related to COVID-19. [Anadolu Agency]

The massive IMF bailouts for coronavirus demonstrate just how much funding is available with just this one institution to support the global economy. IMF head Kristalina Georgieva has even talked about being ready to use the full \$1 trillion available to the bank while other Western leaders have called for the IMF's funding to be increased even further. And the IMF's COVID-19 funding is being provided fully without any conditionalities, Georgieva merely requesting that countries put this funding to the best use. The question is why this vast funding is available at this time but is not available to support third-world countries in alleviating chronic poverty, improving healthcare and education, boosting food security, or to save the 10% of the world population that the World Bank, the IMF's sister organisation, says live in extreme poverty. The answer to this is that the IMF and World Bank were created not to support global wellbeing and prosperity but to sustain the colonial system that supports the economies of the West.

Before World War II, European countries had developed extensive empires, from whose territories they cheaply extracted resources and manpower, while selling them Western manufactures at high rates, paying for which resulted in the depletion of the wealth of colonial territories also. It is this same arrangement that has been continued on a worldwide scale after the end of formal empires, with Western countries continuing to exploit the wealth, resources and manpower of the rest of the world. The purpose of the IMF and the World Bank, created in 1944 as a replacement for formal imperial economic systems, is to stabilise the new global imperial model. Over time, excessive wealth depletion leads to domestic economic instability. The IMF's role in this is more political than economic; the IMF domestic intervenes when instability becomes politically unmanageable, providing immediate funding to weak political governments. And through 'conditionalities' attached to these loans, the IMF ensures the continued implementation of the Capitalist economic system in such countries and a particular set of policies that ensures that these countries can continue to be exploited. This includes prioritising exports, allowing free international capital

flows, and directing expenditure towards massive infrastructure purposed for international trade rather than domestic development.



The West's dependence on economic colonialism is a consequence of their implementation of the failed Capitalist economic system. This system creates a surge of economic activity initially but economic productivity declines as extremely wealthy elite develops at the expense of the rest of the population. This small elite cannot generate the amount of economic activity required to sustain the entire population. Hence it is necessary to look abroad. The condition of Western countries now is that they are even dependent abroad for manufactured products.

Islam was implemented for over a thousand years, and throughout this period built a resilient and dynamic economy genuinely sustained by strong domestic economic activity. Indeed the Islamic economy led the world and is a primary reason for the growing prosperity of the West before they turned to colonialism, as Western countries depended on trade with Muslim lands. Allah (swt) says in the Noble Qur'an:

"It is He who made the earth tame for you - so walk among its slopes and eat of His provision - and to Him is the resurrection." [al-Mulk: 15]

With Allah's permission, the world shall soon see the re-establishment of the Islamic Khilafah (Caliphate) State on the method of the Prophet (saw) that shall unify Muslim lands under its leadership, reject the interference of the foreign disbeliever, implement the Islamic Shari'a, and build again a world-leading civilisation that shall be a source of peace and prosperity for all humankind.

A STATE ADDS A FEAR OF HUNGER TO THAT OF A CORONAVIRUS



In a new measure to curb the global Coronavirus pandemic, the Government has totally shutdown two Muslim highly dominated commercial centers; Eastleigh in Nairobi and Old Town in Mombasa. The Government is now seen playing blame game on its citizens yet it allowed the virus to import in the country.



Primarily, testing is commendable, but for the citizens to brush off the exercise is indeed an indication they have lost their trust in their authorities who issuing empty promises has been their norm. Poor healthcare system and all the public social services have made citizens not to trust State. INTERNATIONAL ORGANIZATIONS SHOULD NOT BE HELD RESPONSIBLE FOR THE HEALTH OF THE WORLD



Trump said during his daily press briefing on the 10th of April that, "over the years, many years, we've been paying them from 300 to 500, and even more, million dollars a year. China has been paying them less than 40 over the years. So we're paying them more than 10 times more than China. And they are very, very China-centric".

Trump's attack on the World Health Organization response to the crisis stems from the desire to deflect from his own failings in handling the crisis, and it highlights a real flaw in the structure and functioning of international organizations under the United Nations umbrella and is supported to some extent by real mistakes made by the World Health Organization.

The WHO tweeted on the 14th of January that "Preliminary investigations conducted by the Chinese authorities have found no clear evidence of human-to-human transmission of the novel coronavirus (2019nCoV) identified in Wuhan, China", but Chinese doctors were trying to warn the world as early as December that human to human transmission was occurring. In addition to this misdirection from the WHO, the WHO was very late in announcing a viral pandemic and this gave national governments a false justification for delaying their responses.

The WHO is widely regarded as an independent entity, but, of course, Trump is correct in that the organization is made up of people from countries across the world and their different agendas must be reflected in the functioning of the organization. The major way this is reflected, however, is not in decisions and pronouncements that support a specific agenda, but by decisions and announcements being filtered through many layers of bureaucracy in an attempt to be free of diplomatic blame before all member states.



"The United Nations has increasingly become a political arena where high officials engage in political give-and-take and where 'interest groups' lobby for their country's interests [...] Political appointees are frequently not loyal to the United Nations, but to their respective governments, upon which they depend for further reward or punishment" (Finger and Hanan 1980). Increasing evidence from other domains suggests that the national identities of bureaucrats affect the decision-making of institutions (Kaja and Werker 2010; Johns 2007)

The result is that Chinese claims must take place over Taiwan's claims, as Taiwan is only recognized by fourteen out of 193 UN member states, and official Chinese government pronouncements take precedence over contradictory claims made by individual Chinese citizens. Furthermore, the bureaucracy ensures slow and careful pronouncements after internal consensus

building to avoid offense. Throughout all of this, it is a human organization and as such the influence of some states can be greater than others in some proportion to the size of these states and the amount of their input. The very concept of an international organization or an international law is flawed as only states can be a source of law. States merely agree to function within the international so-called frameworks in accordance with their power and their judgement as to whether this framework serves their long-term interests to such an extent that they will sacrifice some shortterm interests.

Knowing the limitations conceptually and practically of the WHO as an international body, any sincere leadership should build its actions upon the basis that it is national governments who are responsible for the health of their people, and not the WHO. Trump, therefore, is wrong to blame the WHO for the fact that the US is now at the epicenter of a pandemic, whose real size within their borders far exceeds their capacity to test for it.

evidence to suggest 5G roll-out has either caused the virus to spread or is being used as a cover to accelerate 5G technology.

'Conspiracy theories' exist to give a counter explanation or exposure of information, by and large hidden, from the public on major world events. There are millions who believe the US moon landings were fake. Many Muslims say the Jews had something to do with the 9/11 attacks. Some cite the UK security services being behind the 7/7 London bombings.



'Flat Earth' conventions still gather thousands each year convinced that the earth

is indeed flat and the anti-vaxxers movement gains traction every year when vaccine immunisation comes round.

We all have our own favorite conspiracy theory, however implausible; mine is how in the world Manchester United FC were denied a victory against West Ham on the last day of the 1994/95 football season. Victory at West Ham's ground would have given them the premier league title, but despite dominating the match, hitting the post and the crossbar and the many attempts at goal the final score remained 1-1. Were the opposing players bribed, was the referee short-sighted or was there actually something wrong with the ball. In all seriousness, willing and wanting something to be true doesn't make it true and no doubt my own <u>confirmation bias</u> as a committed Man Utd fan skews how I view that match.

So it's quite easy to dismiss most conspiracy theories or the "tin foil hat" brigade as they are known when they are in the <u>David</u> <u>Icke</u> category, or as a bit of harmless fun when you meet someone who is convinced Elvis is still alive.

Things get a little more difficult when trying to explain how the apparent or accepted wisdom gets unraveled after many years and new opinions or facts get established. The tobacco industry went to extraordinary lengths to insist cigarettes were safe and deny the harmful effects of smoking. Saturated fats being linked to heart disease and the need to adopt a 'low fat diet' was the accepted scientific and nutritional norm for decades. It is only in recent times that the effects of a high carbohydrate/sugar diet in causing obesity and diabetes and the softdrinks multinationals role in misleading millions has emerged. Conspiracy, collusion or incompetence? Maybe it's a mixture of all three.

My own disagreement with conspiracy theorists has less to do with their lack of evidence for their claims, but more their search for a "hidden truth" or revelation of a scandal by governments, politicians and the media. This is not to deny that cover-ups, misinformation and things not being as they seem, do happen. They clearly do.

What if the thing being looked for is actually, as the saying goes, hiding in plain

sight? What if the dominant political, economic and social viewpoint in the world today, secular liberalism and democracy, or liberal values, is the real issue that needs to be addressed?



Anyone questioning this orthodoxy or having another viewpoint is essentially illiberal (note how the suffix 'il' reinforces the perceived correctness of the noun).

The basis of the liberal order is never scrutinized or put to the test in mainstream society. It is deliberately assumed to be the standard that everything is measured against without question. Consider the political system in the UK. Do the masses get to choose the philosophy of the system they live under and the basis of how legislation is made? Not at all. There has never been a referendum with the question to choose one of the following options: secular liberalism; communism or the Islamic Shari'ah? Nor is there likely to be. We are all by now familiar with the daily graphs plotting Covid-19 deaths, new infections and hospital admissions on our television screens. There are very few showing everyday death, graphs the suffering, poverty and misery faced by millions of people across the globe surviving on a few dollars a day. The pandemic will subside, but what will remain unchanged is the secular, liberal worldview that was there all along and its contribution to the sorry state of humanity. The danger is we end up not talking about this at a time when it is most needed. Now, that would be a conspiracy.
